**NATIONAL CONSTITUTION CENTER CELEBRATES AFRICAN AMERICAN HISTORY MONTH*****TD Bank underwrites FREE admission to the Center on Presidents Day, Monday, February 19***

Philadelphia, PA (February 2, 2018) – Throughout February, the National Constitution Center will host a variety of programs in honor of African American History Month. Visitors can explore the museum's main exhibit, *The Story of We the People*, to discover key milestones in African-American history and then test their knowledge at the Center's giant game board activity. Visitors will learn about the history of the Civil War and the Emancipation Proclamation, the background of the 13th, 14th, and 15th amendments, and key figures from the Civil Rights Movement.

TD Bank sponsors African American History Month at the National Constitution Center and underwrites free admission to the Center on Presidents Day, Monday, February 19. Featured programs on Presidents Day include a Meet the Presidents Kids Town Hall, a Presidential Costume Contest, and more. This year marks the fifth consecutive year of TD Bank's sponsorship.

Admission during African American History Month includes access to the National Constitution Center's interactive main exhibit, the signature multimedia, theatrical performance of *Freedom Rising* presented in the Sidney Kimmel Theater, and the iconic *Signers' Hall*.

Visitors also have access to the Center's feature exhibits, including *American Treasures: Documenting the Nation's Founding*, an intimate look at the rarest early drafts of the U.S. Constitution and the Bill of Rights, and *Constituting Liberty: From the Declaration to the Bill of Rights*, highlighting the three most important documents in American history.

In February, visitors can also take advantage of the National Constitution Center's Winter Warm Up sale, which runs through March 31, 2018. Admission prices are discounted to \$10 for adults (usually \$14.50) and \$7.50 for youth ages 6-18 (usually \$11). *This promotion is valid online only; tickets must be purchased in advance.*

Visitors can participate in a family festival while observing both African American History Month and Presidents Day. Visitors will learn about the contributions of African-Americans throughout history and the role of the president and what it takes to be commander in chief during the National Constitution Center's Presidents Day Weekend celebration. Throughout the weekend, the Center will host a variety

of entertaining, educational programs for the whole family, including presidential trivia where visitors can test their knowledge of America's 45 presidents, craft stations, story corners, and more. **Admission to the Center will be free on Presidents Day, Monday, February 19, courtesy of TD Bank.**

### ***America's Town Hall Program* – [Landmark Cases Part 2: Historic Supreme Court Decisions](#)**

Monday, February 19, 6:30 p.m.

On Presidents Day, visitors can join C-SPAN President **Susan Swain**, National Constitution Center President and CEO **Jeffrey Rosen**, and a panel of experts for a discussion which will launch the second season of the C-SPAN series, *Landmark Cases: Historic Supreme Court Decisions*, produced in collaboration with the National Constitution Center. The panel and the series will explore the human stories between the Supreme Court's most historic rulings. **Among the cases featured this season will be *Plessy v. Ferguson*, which allowed racial segregation in public spaces, and other cases pertaining to the 14th Amendment.**

### **Breaking Barriers Show**

#### *Main Exhibit*

The interactive Breaking Barriers show examines the lives of Thurgood Marshall, Bessie Coleman, Jackie Robinson and other groundbreaking African-Americans throughout American history—providing insight into the struggles they faced and the rights they secured for all citizens. Their inspiring stories reveal how one individual's civic actions can impact a nation.

### **Decoding the Document: Emancipation Proclamation Document Workshop**

#### *Main Exhibit*

Visitors can join the Center's education staff and take a closer look at a rare copy of the Emancipation Proclamation, signed by Abraham Lincoln in June 1864. Forty-eight similar copies were sold at the Philadelphia Great Central Sanitary Fair to raise funds for sick and wounded Union soldiers. Of those 48 signed by Lincoln, only 24 are known to survive. ### **African-American History Self-Guided Tour**

#### *Main Exhibit*

Visitors can pick up a flier at the Information Desk to take a self-guided museum tour highlighting important moments in African-American history. Featuring:

- One-of-a-kind artifacts that give a glimpse into the daily lives of free African-Americans in the 1700s who once called the museum's block home.
- The American National Tree, featuring influential African-Americans including Paul Robeson, Fannie Lou Hamer, Hiram Rhodes Revels, and more.
- A rare printing of the Emancipation Proclamation, signed by Abraham Lincoln.
- Original documents from the landmark Supreme Court cases, including *Dred Scott v. Sandford* and *Loving v. Virginia*.
- Artifacts from the March on Washington.
- President Obama inauguration artifacts.

### *Main Lobby*

As part of the Center's interactive daily programming in February, visitors can test their knowledge of African-American history by becoming "pieces" in the Center's giant constitutional board game.
