Philadelphia (January 11, 2016) – The National Constitution Center today announced the winter 2016 lineup for its popular *America's Town Hall* series of constitutional conversations and debates. This year's lineup will explore the timely topics of Immigration, Policing, and the Presidential Election, among others. Guest speakers include former U.S. Secretary of Defense **Robert M. Gates**, political journalist **Jacob Weisberg** and former New York City Schools Chancellor **Joel Klein**.

The Center's *America's Town Hall* series will also travel to San Francisco with the American Constitution Society and the Federalist Society on March 16 to debate *Vergara vs. California*, a landmark dispute over the constitutionality of teacher tenure.
