## **OTHER WAYS TO GIVE**

### **MATCHING GIFTS**

Many employers sponsor matching gift programs and will match charitable contributions made by their employees. To find out how to maximize your gift through your company's matching gift program, please contact your company's Human Resources department or our Development Office at 215.409.6767.

### **GIFTS OF STOCK AND SECURITIES**

Your broker or investment advisor can wire your gift to the National Constitution Center quickly and safely by using the Depository Trust Company (DTC) wire transfer system. A gift of publicly traded securities can be one of the most advantageous ways of giving. A gift of securities held for over one year, such as stocks, generally generates an income tax deduction at the market value of the securities, regardless of the price paid or basis of the securities. Moreover, the capital gains tax is avoided through such a gift.

## **IRA CHARITABLE ROLLOVER**
